**ORDINANCE #4291**, February 14, 2011

WHEREAS, the Sheriff's Office has been awarded a grant in the amount of \$300.00 by the Missouri Safety Center for the Youth Seat Belt Enforcement Campaign, for the period March 15 through March 31, 2011; and,

WHEREAS, this campaign will encourage young drivers to use seatbelts in an effort to reduce

fatalities; and,

WHEREAS, the Sheriff recommends the use of funds for reimbursement of overtime used for the campaign throughout the County, pursuant to the attached agreement with the Missouri Safety Center; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending account; now therefore,
