ORDINANCE #4292, February 14, 2011

WHEREAS, the Sheriff's Office has been awarded a grant in the amount of \$500.00 by the Missouri Safety Center for the St. Patrick's Weekend DWI Enforcement Campaign 2011, for the period March 16 through March 20, 2011; and,

WHEREAS, this campaign will increase enforcement of impaired drivers in an effort to reduce

fatalities during St. Patrick's Day celebrations; and,

WHEREAS, the Sheriff recommends the use of funds for reimbursement of overtime used for the campaign throughout the County, pursuant to the attached agreement with the Missouri Safety Center; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending account; now therefore,
