BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature be authorized to hold a closed meeting during the regularly scheduled meeting of the Legislature on Monday, May 23, 2011, pursuant to section 610.021(1), RSMo, and closing all records prepared in connection therewith.
