ORDINANCE #4396, March 5, 2012

INTRODUCED BY James D. Tindall, County Legislator

WHEREAS, the Jackson County Drug Task Force (JCETF) and the Federal Bureau of Investigation have formed the Organized Crime Drug Enforcement Task Force (OCETF) to conduct a joint federal drug investigation for the period of October 1, 2011, through September 30, 2012; and,

WHEREAS, the overtime costs incurred by the JCETF for this investigation will be reimbursed by the OCETF, in an amount not to exceed \$25,000.00; and,

WHEREAS, an appropriation is necessary to place the projected funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
