**RESOLUTION #17842,** March 5, 2012

**INTRODUCED BY** Bob Spence, County Legislator

WHEREAS, by Ordinance 4379, dated January 3, 2012, the Legislature did authorize the vacation of

a portion of Old Lexington Road due to the proposed closing of an at-grade crossing by the Union

Pacific Railroad to reduce hazardous railroad crossings; and,

WHEREAS, the Missouri Highways and Transportation Commission recommends the execution of the attached Supplemental Agreement for the purpose of setting forth the mutual understanding and obligations of each entity with regards to the closing of the Old Lexington Road crossing; and,

WHEREAS, the execution of the attached Supplemental Agreement with the Missouri Highways and Transportation Commission and the Union Pacific Railroad Company is in the best interest of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the attached Supplemental Agreement is hereby approved and that the County Executive is hereby authorized to execute on behalf of the County the Agreement and any other documents necessary to give effect to this Resolution.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
