WHEREAS, the Shepherd Center of Kansas City Central has submitted a funding request as a subcontracting agency of the Mid-America Regional Council (MARC), for its Senior Companion Program; File #: 18076, Version: 0

and,

WHEREAS, this program will provide assistance to low-income individuals in Jackson County who

are 55 years of age or older and are in need of in-home support services; and,

WHEREAS, in the past this County-funded program was provided by Westport Cooperative Services

Corporation, which has now merged with the Shepherd Center of Kansas City Central; and,

WHEREAS, the execution of this Cooperative Agreement with MARC, in the amount of \$20,000.00,

to be passed-through to Shepherd Center of Kansas City Central, is in the best interest of the health,

welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive

be and hereby is authorized to execute a Cooperative Agreement with MARC, authorizing a

subcontract with Shepherd Center of Kansas City Central, in the amount of \$20,000.00, in a form to

be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is

authorized to make all payments, including final payment on the agreement.
