ORDINANCE NO. 4506, February 19, 2013

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, by Ordinance 4273, dated November 29, 2010, the Legislature did authorize the

issuance, sale, and delivery of not to exceed \$1,180,000.00 principal amount of tax exempt special

obligation bonds (MyARTS Building Project) Series 2010 to finance the costs of capital improvements

to the MyARTS building; and,

WHEREAS, the County's underwriter has advised that the County can save substantial interest costs by an early redemption of these bonds; and,

WHEREAS, the funds necessary for the early redemption of the 2010 B Special Obligation Bonds were appropriated in the 2013 Anti-Drug Sales Tax Fund; and,

WHEREAS, the Director of Finance and Purchasing projects that \$915,000.00 will be necessary to redeem the bonds; and,

WHEREAS, an appropriation is necessary to place the bond funds in the proper account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the undesignated fund balance of the 2013 Special Obligation Bond Debt Service Fund:
