WHEREAS, the Kansas City Chapter currently has 206 members locally who support the organization's goal of helping local Hispanics to work toward their educational and professional aspirations while promoting cultural pride and service to the community; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature hereby congratulates the National Society of Hispanic MBAs, on the occasion of its 25th anniversary and extends sincere best wishes for continued success in the future.
