WHEREAS, it is now appropriate that the Legislature adopt this Resolution appointing a new member
to the commission for the balance of the unexpired term to expire December 31, 2015; now therefore
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following-named person be and hereby is appointed to the Kansas City Zoological District Commission for a term to
expire December 31, 2015, under section 184.506, RSMo Supp. 2012:
