INTRODUCED BY Theresa Garza Ruiz, County Legislator

WHEREAS, by Resolution 17240, dated April 12, 2010, the Legislature did award a twelve-month term and supply contract with three twelve-month options to extend for the furnishing of mail services for use by the Office Services Division of the Finance and Purchasing Department, to Strahm Automation and Mailing Services of Kansas City (Jackson County), MO, under the terms and conditions of Invitation to Bid No. 50-09.

WHEREAS, the Director of Finance and Purchasing is requesting the extension of that contract

through July 15, 2015, to allow the County's agreement to expire at the same time as the City of

Kansas City, Missouri's mail service's contract; and,

WHEREAS, this will allow the County and the City to issue a joint bid to insure the lowest and best

pricing; and,

WHEREAS, Strahm Automation has agreed to this extension at the same terms and pricing; now

therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the contract with

Strahm Automation and Mailing Services be extended through July 31, 2015, as recommended by

the Director of Finance and Purchasing, and that the Director be, and is hereby, authorized to

execute for the County any documents necessary to the accomplishment of the extension; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is

authorized to make all payments, including final payment on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the

Legislature.
