**AN ORDINANCE** amending the zoning districts established pursuant to the Unified Development Code by changing a certain 3.33 ± acre tract from District AG (Agricultural) to District RE (Residential Estates).

### ORDINANCE NO. 4615, April 7, 2014

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "AG" (Agricultural) District and the

"RE" (Residential Estates) District, so that there will be transferred from District AG to District RE, a 3.33 ± acre tract of land commonly known as 8205 S. Stillhouse Road, Oak Grove, MO, and specifically described as follows:

**Description:** Lot 3, Tri Acres, a subdivision in Jackson County, Missouri

Section 2. The Legislature, pursuant to the application of James R. Haynes, (RZ-2014-504), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission voted 7 to 0 to recommend APPROVAL of this application after a public hearing on March 20, 2014, does adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
