RESOLUTION 18539, June 9, 2014

INTRODUCED BY James D. Tindall, County Legislator

WHEREAS, the Director of Finance and Purchasing has solicited bids for the furnishing of police

body armor, supplies, and equipment for use by the Sheriff's Office, the Department of Corrections,

the Drug Task Force, and Park Safety and Enforcement; and,

WHEREAS, a total of twenty-seven notifications were distributed and five responses were received, one of which was determined to be non-responsive and the three lowest and best bids, as follows:

Ray O'Herron Co., Inc. Danville, IL

Ed Roehr Safety Products St. Louis, MO

and,

WHEREAS, following evaluation of the bids submitted, the Director of Finance and Purchasing recommends the award of twenty-four month term and supply contracts with two twelve-month options to extend, to Ed Roehr Safety Products of St. Louis, MO, Lynn Peavey of Lenexa, KS, and Ray O'Herron of Danville, IL, as the lowest and best bidders; and,

WHEREAS, a split award is requested to take advantage of the best rates and to provide additional sources when one of the vendors may not have the required suppliers and/or equipment available; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any amount, with the availability of funds for specific purchases remaining subject to annual appropriation; now therefore, BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the award be made as recommended by the Director of Finance and Purchasing, and that the Director be and hereby is authorized to execute for the County any documents necessary to the accomplishment of the purchase; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments, including final payments on the contracts, to the extent that sufficient appropriations are

contained in the then current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
