ORDINANCE NO. 4645, July 28, 2014

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "AG" (Agricultural) District and the "RS" (Residential Suburban) District, so that there will be transferred from District AG to District RS, a tract of land known as 25208 E. 30th Street, Greenwood, MO, and specifically described as follows:

Description: Lot 40, Trophy Estates, a subdivision in Jackson County, Missouri.

Section 2. The Legislature, pursuant to the application of Andrew and Jennifer Wuebker, (RZ-2014-507), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission voted 8 to 0 to recommend APPROVAL of this application after a public hearing on July 17, 2014, does adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
