WHEREAS, pursuant to section 1030.2 <u>Jackson County Code</u>, 1984, the Director of Finance and Purchasing recommends this purchase as an acquisition from another government, at an actual cost

WHEREAS, the Sheriff's Office desires to use Federal Forfeiture Funds to fund the cost of this vehicle and to acquire security cameras, equipment, and in-car computers via existing term and supply contracts; and,

WHEREAS, an appropriation is necessary to place funds available in the Federal Forfeiture Fund in the proper spending accounts for these purchases; now therefore,
