that the Director be, and is hereby, authorized to execute for the County any documents necessary

for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments, including final payment on the contracts, to the extent that sufficient appropriations to the

using spending agencies are contained in the then current Jackson County budget.
