INTRODUCED BY Alfred Jordan, County Legislator

WHEREAS, by Resolution 17575, dated April 18, 2011, the Legislature did authorize a Consulting Agreement with Tusa Consulting Services of Covington, LA, for a radio system study and conceptual design to assist the County in the Federal Communications Commission mandate to convert its public radio system from a wideband analog system to a narrowband system; and,

WHEREAS, subsequent addenda authorized by the Legislature have extended the Agreement with

Tusa through December 31, 2014, and expanded the Scope of Work to include assistance with the

implementation of an updated radio system at the new Sheriff's Headquarters; and,

WHEREAS, it is now recommended that the County join the Eastern Jackson County radio system to

improve the access in the Independence/Blue Springs area; and,

WHEREAS, additionally it is recommended that Tusa Consulting provide assistance to improve local

portable coverage in the southern portions of the County; and,

WHEREAS, the execution of an extension to the Agreement with Tusa Consulting at an additional

cost to the County in the amount of \$4,860.00 is in the best interests of the health, safety, and

welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive

be and hereby is authorized to execute an extension to the Agreement with Tusa Consulting Services

through December 31, 2015, a an additional cost to the County in the amount of \$4,860.00, in a form

to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is

authorized to make all payments, including final payment on the agreement and all addenda thereto.
