BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "RR" (Residential Ranchette) District and the "AG" (Agricultural) District, so that there will be transferred from District RR to District AG, a tract

of land commonly known as 2306 S. Borgman Road, Oak Grove, MO, and specifically described as

follows:

Description: Lot 1, Brotherton Dickson Acres, a subdivision in Jackson County, Missouri

<u>Section 2</u>. The Legislature, pursuant to the application of the Daniel and Darcy Brotherton (RZ-2015-517), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission voted 8 to 0 to recommend <u>APPROVAL</u> of this application after a public hearing on May 21, 2015, does adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
