**INTRODUCED BY** Alfred Jordan, County Legislator

WHEREAS, by Ordinance 4662, dated September 15, 2014, the Legislature did authorize the acceptance of a grant in the amount of \$160,255.00 from the Missouri Department of Transportation for the Sheriff's Office's DWI Traffic Safety Unit Salary Grant, for the period October 1, 2014, through September 30, 2015; and,

WHEREAS, the Missouri Department of Transportation has authorized an amendment to the budget for the grant award to allow \$12,850.00 of grant funds to be used for an additional uniform allowance

and pension funds, at no additional cost to the County; and,

WHEREAS, a transfer is necessary in order to place these funds in the proper spending accounts;

WHEREAS, the County Executive recommends said transfer; now therefore,
