WHEREAS, the Information Technology Department has a need for ongoing hardware and software maintenance and service of the VoIP Telephone System for the upcoming twelve-month period; and,

WHEREAS, the Director of Finance and Purchasing has solicited bids on Request for Proposals No. 32-15 for the furnishing hardware and software maintenance, service, and monitoring of the County's

Avaya telephone system; and,

WHEREAS, a total of twenty-eight notifications were distributed and three responses were received and evaluated as follows:

WHEREAS, the Director of Finance and Purchasing recommends the award of a twenty-four month term and supply contract with two twelve-month options to extend to SKC Communications of Shawnee Mission, KS, as the lowest and best bidder as set forth in the attached recapitulation and analysis; now therefore,
