WHEREAS, by Resolution 17650, dated August 22, 2011, the Legislature did authorize the

execution of a Cooperative Agreement with the City of Kansas City, Missouri, relating to the

extension of the Little Blue Trace Trail between Lee's Summit Road and Longview Lake; and,

WHEREAS, the County has now received funds in the amount of \$675,000.00 from the City of Kansas City, Missouri, relating to this project; and,

WHEREAS, an appropriation is necessary to place these funds in the appropriate spending accounts; now therefore,
