ORDINANCE NO. 4800, November 16, 2015

WHEREAS, Garry Cunningham has submitted a request to amend the Zoning Order of Jackson County, Missouri, currently under consideration by the Legislature as Ordinance 4799, dated November 16, 2015; and,

WHEREAS, as part of Mr. Cunningham's request, vacation of Lots 1 - 3 and Tract A within the subdivision plat "Twin Oaks Estates," is necessary; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. Pursuant to the United Development Code of Jackson County, section 24003.24, <u>Jackson County Code</u>, 1984, Lots 1 - 3 and Tract A within the subdivision "Twin Oaks Estates" is hereby vacated, said tract being specifically described as follows:

Description: Twin Oak Estates, Lots 1 - 3 & Tract A, a subdivision in Jackson County, Missouri

<u>Section 2</u>. The Legislature, pursuant to the application of Garry Cunningham (LA-2015-034), requesting the vacation embodied in this Ordinance and with notice that the Jackson County Plan Commission voted 7 to 0 to recommend <u>APPROVAL</u> of this application at a public hearing on October 15, 2015, does adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
