be awarded based on the lowest prices proposed to be charged to the inmate customers, with a

twenty percent commission to be payable to the County; and,

WHEREAS, a total of thirteen solicitations were distributed and three responses were received and evaluated from the following:

WHEREAS, the Director of Finance and Purchasing recommends the award of a thirty-six month term and supply contract with two twelve-month options to extend to Keefe Commissary Network, LLC of St. Louis, MO, as the best bidder; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as

recommended by the Director of Finance and Purchasing, and that the Director be and hereby is

authorized to execute for the County any documents necessary for the accomplishment of the award.
