## **RESOLUTION NO. 19054**, January 19, 2016

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, by Executive Order No. 15-21, the then County Executive appointed Joseph Piccinini to

serve as the County's Director of Department of Corrections effective December 7, 2015; and,

WHEREAS, at that time, in an effort to support professional management for Jackson County, the

County Executive recommended an employment agreement for this top-level management position

with the County; and,

WHEREAS, this agreement outlines the basis for continued employment, termination, and severance,

a practice that is recommended by the International City/County Management Association and promotes the separation of the professional management of the County from political offices; and,

WHEREAS, the execution of this Employment Agreement is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Employment Agreement on behalf of the County; and,

BE IT FURTHER RESOLVED that all County officials be and hereby are authorized to undertake all actions required by this Agreement.
