WHEREAS, the Director of Finance and Purchasing recommends that said property be declared

surplus and unusable and sold at auction; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the property within the various County departments and the Sixteenth Judicial Circuit Court further described and itemized in Exhibit A, be and hereby is declared surplus, and that the Director of Finance and Purchasing be and hereby is authorized to dispose of it as provided for in Chapter 11, <u>Jackson County Code</u>, 1984.
