WHEREAS, by Resolution 19081, dated February 22, 2016, the Legislature did award a contract to Guier Fence Company of Blue Springs, MO, for the furnishing and installation of fencing for use by the Parks + Rec Department at the Frank White, Jr. Softball Complex, under the terms and conditions set forth in the City of Independence, Missouri Contract No 386-15, an existing government contract, at an actual cost to the County not to exceed \$68,000.00; and,

WHEREAS, by Resolution 19112, dated March 28, 2016, the Legislature authorized an addendum to

the contract with Guier Fence Company for additional fencing needed to replace existing fencing that

is bowing, curling, and discolored; and,

WHEREAS, in the course of completing this project, it was determined that additional materials and

labor are needed to finalize this work; and,

WHEREAS, the Director of Finance and Purchasing recommends a Second Addendum to the

contract with Gueir Fence, at an additional cost to the County in the amount of \$24,000.00 for these

additional renovations; and,

WHEREAS, the execution of this Second Addendum to this contract is in the best interests of the

health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of

Finance and Purchasing be and hereby is authorized to execute a Second Addendum to the contract

with Guier Fencing; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is

authorized to make all payments, including final payment on the contract and all addenda thereto.
