ORDINANCE 4862, July 11, 2016

WHEREAS, by Ordinance 4736, dated May 18, 2015, the Legislature did authorize the acceptance of a grant from the U.S. Office of National Drug Control Policy Midwest High Intensity Drug Trafficking

Area (HIDTA) in the amount of \$63,315.00, for the period of January 1, 2015, through December 31, 2016; and,

WHEREAS, HIDTA has authorized additional grant funds in the amount of \$21,286.00 to support the salary for an intelligence analyst in the Jackson County Sheriff's Office; and,

WHEREAS, the attached addendum to the Memorandum of Understanding with the Kansas Bureau of Investigation provides a suitable mechanism by which to implement this arrangement; and,

WHEREAS, an appropriation is necessary to place these grant funds in the appropriate spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made from the undesignated fund balance of the 2016 Grant Fund:
