INTRODUCED BY Dan Tarwater III, County Legislator

WHEREAS, by Resolution 18893, dated July 27, 2015, the Legislature did authorize the execution of

a Consulting Agreement with Data Driven Consulting, LLC, of Kansas City, MO, for the furnishing of

consulting services to evaluate the alignment of the Prosecuting Attorney's Office as part of its crime

reduction programs and to provide a detailed and academic evaluation of the Teens in Transition

Program; and,

WHEREAS, by Resolution 19006, dated November 16, 2015, the Legislature did authorize an addendum to the Consulting Agreement with Data Driven Consulting for additional costs and administrative fees associated with facilitating the training and technical assistance of members of the Prosecuting Attorney's Office, through March 31, 2016; and,

WHEREAS, the Prosecuting Attorney's Office has requested an extension of the Agreement with Data Driven through December 31, 2016, at no additional cost to the County; now therefore, BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute an extension to the Agreement with Data Driven Consulting, in a form to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the agreement and addenda thereto.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
