ORDINANCE NO. 4894, September 19, 2016

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, pursuant to sections 205.975 through 205.990, RSMo, as amended, and the vote of the qualified voters of November 4, 1980, and June 2, 1991, there was established for the Jackson County Community Mental Health Fund a tax levy at the annual rate not to exceed thirteen and three tenths (13.3) cents per one hundred dollars of assessed valuation on all taxable property in Jackson County, Missouri; and,

WHEREAS, sections 137.073 and 137.115, RSMo, and Missouri Constitution, article X, section 22,
require tax levies to be revised as a result of general reassessment; now therefore,
BE IT ORDAINED by the County Legislature of Jackson County, Missouri that, after calculation of the
levy revision mandated by statute and the Constitution, there is hereby levied for the 2016 tax year
the rate of twelve and one hundredths (12.01) cents per one hundred dollars of assessed valuation
on all taxable property for the Jackson County Community Mental Health Fund.
