AN ORDINANCE setting the 2016 merchants and manufacturers' inventory replacement tax levy.

ORDINANCE NO. 4895, September 19, 2016

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, Missouri Constitution, article X, section 6 and section 139.600, RSMo, provide for a tax levy to be charged against the assessed valuation of real property listed in subclass 3 (utility, industrial, commercial and railroad property) of class one property (real estate), to replace revenues lost from the exemption of merchants' and manufacturers' inventories; and,

WHEREAS, this replacement levy has been calculated in accordance with section 139.600, RSMo;
now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the 2016 replacement
levy be set at the rate of \$1.437 per one hundred dollars of assessed valuation of real property in
subclass 3 of class one property.
