INTRODUCED BY Greg Grounds, County Legislator

WHEREAS, the Director of Finance and Purchasing has solicited formal written bids on Invitation to Bid No. 54-16 for the furnishing of crushed rock for use by various County departments for the upcoming twenty-four month period; and,

WHEREAS, a total of seventeen notifications were distributed and four responses received, one of

which was rejected as non-responsive, with the remaining three bids thereon from the following:

and,

WHEREAS, following evaluation of the bids submitted, the Director of Finance and Purchasing recommends award of a twenty-four month term and supply contract with three twelve-month options to extend to AA Quarry, LLC, of Pleasant Hill, MO, as the lowest and best bidder; and,

WHEREAS, this award is made on an as-needed basis and does not obligate Jackson County to pay any specific amount, with the availability of funds for specific purchases being subject to annual appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award and any necessary extensions; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment, on the contracts and subsequent extensions, to the extent that

sufficient appropriations to the using spending agencies are contained in the then current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
