WHEREAS, by Resolution 19052, dated January 19, 2016, the Legislature did authorize the execution of a Cooperative Agreement, in the amount of \$16,940.00, with the Jackson County Soil and Water Conservation District for conservation efforts for the benefit and preservation of the road and bridge rights-of-way in unincorporated Jackson County; and,

WHEREAS, it is necessary to revise the original budget presented by the Jackson County Soil and Water Conservation District due to the need for additional printing supplies; and,
