RESOLUTION NO. 19296, October 24, 2016

INTRODUCED BY Alfred Jordan, County Legislator

WHEREAS, the Jackson County Constructing Futures Program is a unique public-private partnership designed to provide a structured pathway to allow former drug offenders to enter the construction industry, and at the same time provide permanent housing to those in need; and,

WHEREAS, the project will allow drug offenders and unskilled individuals living in poverty to learn the

construction trade by rehabilitating houses that can then be occupied by a family struggling with homelessness; and,

WHEREAS, the Administration recommends that Connections to Success, Inc., of Kansas City (Jackson County), MO, serve as the manager for the 2016 Constructing Futures Program, at a cost to the County in the amount of \$108,629.00; and,

WHEREAS, a transfer is necessary to place a portion of the funds needed for this program in the appropriate spending account; and,

WHEREAS, the County Executive recommends this transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer within the 2016 General Fund be and hereby is made:
