A RESOLUTION authorizing the extension of the Agreement with Niles Home for Children of Kansas City, MO, for the furnishing of anti-drug treatment activities and purposes, at no additional cost to the County.

RESOLUTION NO. 19316, November 28, 2016

INTRODUCED BY Dan Tarwater III, County Legislator

WHEREAS, by Resolution 19063, dated January 25, 2016, the Legislature did authorize the execution of an Agreement with Niles Home for Children of Kansas City, MO, for the furnishing of anti-drug treatment activities and purposes, for the period January 1, 2016, through December 31, 2016, at a cost to the County in the amount of \$24,000.00; and,

WHEREAS, the COMBAT staff has recommended that the County Executive be authorized to extend the Agreement with Niles Home for an additional one-year period, through December 31, 2017, at no additional cost to the County; and,

WHEREAS, the recommended extension will allow this agency to utilize the allocation provided to it in 2016; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute an extension to the Agreement with Niles Home for Children, until December 31, 2017, in a form to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the Agreement and addendum thereto.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
