RESOLUTION NO. 19361, January 23, 2017

INTRODUCED BY Scott Burnett, County Legislator

WHEREAS, by Ordinance 4932, dated November 14, 2016, the Legislature did adopt the 2017

Jackson County budget, which was ultimately signed by the County Executive; and,

WHEREAS, thereafter the County Counselor issued an opinion concluding that the appropriations

from the 2017 Anti-Drug Sales Tax Fund contained in the budget were legally deficient; and,

WHEREAS, a transfer is necessary in order to correct the deficiency and amend the adopted 2017

Jackson County budget to reflect a negotiated compromise; and,

WHEREAS, said transfer is contingent upon the adoption of Ordinance No. 4955, dated January 23,

2017, now under consideration by the Legislature; and,

WHEREAS, the County Executive recommends this transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer
