A RESOLUTION partially rescinding Resolution 18329, dated November 25, 2013, and awarding a twenty-four month term and supply contract for the furnishing of copier leasing services for use County-wide to All Copy/Office Business Solutions f/k/a Knighton Business Solutions of Overland Park, KS, under the terms and conditions of Invitation to Bid No. 58-13.

RESOLUTION NO. 19401, March 6, 2017

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, by Resolution 18329, dated November 25, 2013, the Legislature did award a thirty-six month term and supply contract with two twelve-month options to extend for the furnishing of copier leasing services for use County-wide to All Copy/Office Business Solutions f/k/a Knighton Business Solutions of Overland Park, KS, under the terms and conditions of Invitation to Bid No. 58-13; and,

WHEREAS, All Copy/Office Business Solutions has notified the Director of Finance and Purchasing that the County will receive a twenty percent discount on the renewal term if the contract is awarded as a twenty-four month renewal, rather than the stated two twelve-month renewal periods; and,

WHEREAS, said discount will result in a \$21,760.56 annual savings to the County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of Finance and Purchasing be and hereby is authorized to execute a twenty-four month extension to the term and supply contract with All Copy/Office Business Solutions; and,

BE IT FURTHER RESOLVED that the portion of Resolution 18329, dated November 25, 2013, related to the renewal options of the contract is hereby rescinded.
