WHEREAS, the Houston High Intensity Drug Trafficking Area (HHIDTA), is a multi-jurisdictional

public safety program that was established to reduce drug trafficking and production in the United

States; and,

WHEREAS, the Sheriff recommends the execution of the attached Memorandum of Understanding

with the HHIDTA for the sharing of electronic data information, specifically related to the County's automated license plate readers, at no cost to the County; and,

WHEREAS, the execution of the attached MOU is in the best interests of the health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Memorandum of Understanding with the Houston High Intensity Drug Trafficking Area, at no cost to the County.
