WHEREAS, in 2015, the Sixteenth Judicial Circuit Court (the Court) entered into an agreement with Everbridge, Inc., to provide an interactive communications service software called Nixle; and,

WHEREAS, the County desires to utilize this software to provide automated notifications to associates regarding inclement weather and other messages as needed, at a cost to the County for

WHEREAS, the attached Memorandum of Understanding between the County and the Court sets out
the rights and responsibilities of each party related to this software purchase, which may be renewed
annually at the agreement of both parties; and,
WHEREAS, execution of the attached MOU is in the best interests of the health, safety, and welfare
of the citizens of Jackson County; now therefore,
BE IT RESOLVED by the Legislature of Jackson County, Missouri, that the County Executive be and
hereby is authorized to execute the attached Memorandum of Understanding with the Sixteenth
Judicial Circuit Court, at a cost to the County not to exceed \$2,075.00; and,
BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is
authorized to make all payments, including final payment on the Agreement and extensions thereto,
subject to appropriation in the then current Jackson County budget.
Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
