WHEREAS, the COMBAT staff recommends a Cooperative Agreement with G.A. Dumas, LLC, of Kansas City, Missouri, for the furnishing of substance abuse and cognitive restructuring services to clients of the NoVA project, at a cost to the County not to exceed \$8,000.00; and,

WHEREAS, execution of an agreement for the furnishing of these services is in the best interests of the health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the contract.
