WHEREAS, the Missouri Department of Transportation, Traffic and Highway Safety Division, has awarded the Sheriff's Office the Impaired Driving Enforcement grant in the amount of \$20,628.00, for the period October 1, 2017, through September 30, 2018; and,

WHEREAS, the Sheriff recommends the use of the grant funds for reimbursement of overtime used

for enforcement programs to decrease injuries and fatality crashes due to impaired driving; and,
