WHEREAS, the Department of Corrections has a need for upgraded security cameras and repair services for the existing security cameras within the detention facility; and,

WHEREAS, the Director of Finance and Purchasing has solicited bids on Invitation to Bid 52-17 for

these products and services; and,

WHEREAS, a total of nineteen notifications were distributed and two bids were received from the following:

WHEREAS, the Director of Finance and Purchasing recommends that the contract be awarded to Midwest Digital Systems of Riverside, MO, under the terms and conditions of Invitation to Bid 52-17, as the lowest and best bidder, as set forth in the attached recapitulation and analysis; and,

WHEREAS, this award is made on an as needed basis and does not obligate the County to pay any specific amount, with the availability of funds for specific purchases being subject to annual appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be and hereby is authorized to execute for the County any documents necessary for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make

all payments, including final payment on the contract, to the extent that sufficient appropriations to the using spending agencies are contained in the then current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
