WHEREAS, by Resolution 19562, dated August 22, 2017, the Legislature did authorize the award of

a contract to Cornerstone Detention Products of Madison, AL, for the repair and replacement of

certain swing cell doors and corridor sliding doors within the Detention Center; and,

WHEREAS, the Department of Corrections has a need for the replacement of an additional forty-nine

sliding doors within the Detention Center; and,

WHEREAS, pursuant to section 1030.4 of the <u>Jackson County Code</u>, 1984, the Director of Finance

and Purchasing recommends an Addendum to the Agreement for these services with Cornerstone

Detention Products of Madison, AL, at an additional cost to the County not to exceed \$533,559.00,

under the terms and conditions of the GSA Contract No. GS-07F-269AA, an existing government

contract; and,

WHEREAS, the Director of Finance and Purchasing recommends this purchase under the terms and

conditions set forth in the GSA Contract, due to the volume discounts offered to large entities; and,

WHEREAS, an appropriation is needed to place the funds required for this purchase in the proper

spending account; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,
