WHEREAS, the remaining surplus property listed on Exhibits B and C will be sold at auction; now
therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the property within the
various County departments further described and itemized in Exhibits A, B, and C, be and hereby is
declared surplus, and that the Director of Finance and Purchasing be and hereby is authorized to
dispose of it as indicated and as provided for in Chapter 11, <u>Jackson</u> <u>County</u> <u>Code</u> , 1984.
