WHEREAS, the Jackson County Drug Task Force (JCDTF) and the U.S. Department of Justice's Drug Enforcement Administration have formed the Organized Crime Drug Enforcement Task Force (OCDETF) to conduct a joint federal drug investigation, OCDETF Case No. WC-MOW-0319, "Operation Empty Pockets", for the period of October 1, 2017, through September 30, 2018; and,
