WHEREAS, the Chief Administrative Officer has recommended the adoption of this Resolution,

without waiving any previous position taken in reliance upon the memorandum of the County

Counselor dated December 22, 2017, regarding Ordinance 5062, and without waiving any position

taken in reliance upon other legal memorandums provided by the Office of the County Counselor;

WHEREAS, the Legislature recognizes that funds identified as Reserve Funds in the adopted 2018

budget within the General Fund are required to be designated for use for the Public Employees

Recognition Day awards ceremony; and,

WHEREAS, the Chief Administrative Officer has requested that the funds identified in this Resolution

be made available for such use by the Finance and Purchasing Department within the 2018 budget;

WHEREAS the Legislature agrees that funds described in this Resolution should be made available

for such use by posting to certain budget line items in the General Fund non-departmental budget or
