WHEREAS, the Facilities Management Division of the Public Works Department has a need for

HVAC products, installation, and service to maintain its current Johnson Controls HVAC products and

systems; and,

WHEREAS, under section 1030.4, <u>Jackson County Code</u>, 1984, the Department of Finance and Purchasing recommends a three-year planned service agreement with Johnson Controls, Inc., of Lenexa, KS, under the terms and conditions of U.S. General Services Administration Contract GS-06F-0060P; and,

WHEREAS, the Department recommends award under section 1030.4 for the reason that this will allow the County to take advantage of discounts offered to large entities; and,

WHEREAS, under the proposed agreement, the first-year cost to the County would be \$7,396.00, with price increases of up to 3% permitted in each of the two subsequent years; and,

WHEREAS, it is appropriate that Resolution 19786, dated March 26, 2018, which previously awarded a one-year contract for these services, be rescinded; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made under the existing government contract as recommended by the Department of Finance and Purchasing, and that the Department be and is hereby, authorized to execute for the County any documents necessary for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Department of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agency are contained in the then current Jackson County budget; and, BE IT FURTHER RESOLVED that the portion of Resolution 19786, dated March 26, 2018 that awarded the previous contract, be and hereby is rescinded.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
