WHEREAS, the Prosecuting Attorney's Office requests to contract with Karpel Solutions of St. Louis, MO, for the use of Karpel's eDiscovery Services that will work with the office's existing case management and criminal history reporting software; and,

WHEREAS, Karpel Solutions is the developer of the existing case management and criminal history reporting software and is considered as sole source for the upgrades or enhancements to the Prosecuting Attorney’s Office existing service; and,

WHEREAS, pursuant to section 1030.1 of the Jackson County Code, the Director of the Department of Finance and Purchasing, recommends the award of this contract, as a sole source purchase; and,

WHEREAS, a transfer is necessary to fund this purchase; now therefore,
