A RESOLUTION authorizing the County Executive to execute addenda to the Cooperative Agreements with Hope House, Newhouse, Rose Brooks and Synergy domestic violence shelters in order to provide assistance to victims of domestic violence during 2018, at an aggregate cost to the County not to exceed \$66,217.00.

RESOLUTION NO. 20064, December 3, 2018

INTRODUCED BY Crystal Williams, County Legislator

WHEREAS, by Resolution 19741, dated February 26, 2018, the Legislature did authorize the execution of cooperative agreements with the shelters in an aggregate amount of \$131,454.00; and,

WHEREAS, Hope House, New House, and Rose Brooks domestic violence shelters ("Shelters") are not-for-profit organizations providing assistance to victims of domestic violence; and,

WHEREAS, it is in the best interests of the public health, safety, and welfare of the citizens of

Jackson County to provide assistance to the victims of domestic violence through funding of these

shelters; and,

WHEREAS, pursuant to section 8700., <u>Jackson County Code</u>, 1984, the Board of Domestic Violence

Shelters ("Board") was established to administer the distribution of fees collected pursuant to state

statutes and the Code; and,

WHEREAS, in order to allocate the remainder of the fees collected in 2018, the Board recommends

that the County Executive be authorized to execute amendments to the cooperative agreements with

the domestic violence shelters in the amount of \$19,644.00 for Hope House, Rose Brooks and New

House and \$7,284 for Synergy, at an aggregate cost to the County not to exceed \$66,217.00; now

therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive

be and hereby is authorized to execute the addenda, in a form to be approved by the County

Counselor, with Hope House, New House, and Rose Brooks and Synergy domestic violence shelters,

to allocate the fees collected in the second half of 2018.

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is

authorized to make all payments, including final payments on the contracts and addenda thereto.
