WHEREAS, the Director of Parks + Rec desires to enter into an intergovernmental agreement with

the City of Lee's Summit Parks and Recreation Department for access across the County's parking

lot adjacent to the Longview Community Center for the City's maintenance vehicles; and,

WHEREAS, a Intergovernmental Agreement between the City of Lee's Summit and the County will

allow the Parks + Rec Department to utilize the parking lot at the Community Center for their annual Trip the Lights' bicycle event; and,

WHEREAS, the City of Lee's Summit Parks and Recreation Department has agreed to the costshare of future maintenance and improvements to the County's parking area; and,

WHEREAS, the Director of Parks + Rec recommends the execution of an intergovernmental agreement with the City of Lee's Summit; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive

be and hereby is authorized to execute the attached Intergovernmental Agreement with the City of

Lee's Summit.
