WHEREAS, the Director of Finance and Purchasing has determined that, due to higher volume

discounts offered to larger entities, award under the existing government contract is appropriate in

accordance with section 1030.4 of the County Code; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay

any amount, with the availability of funds for specific purchases remaining subject to annual

appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as

recommended by the Director of Finance and Purchasing, and that the Director be and hereby is

authorized to execute for the County any documents necessary to the accomplishment of the award;

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments, including final payment on the contract, to the extent sufficient appropriations to the using

spending agency are contained in the then current Jackson County budget.
