WHEREAS, section 1030.1, <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items or services to be purchased can be obtained from only one source and requires notification of and approval by the Legislature on such sole source purchases exceeding \$25,000.00; and,

WHEREAS, the Director of Finance and Purchasing recommends a twelve-month term and supply

contract, with three twelve-month options to extend, for the furnishing of softball umpire services with

Eastern Jackson County USSSA Umpire Association of Independence, MO, for use by the Parks +

Rec Department; and,

WHEREAS, the Director further recommends that he not take competitive bids with regard to said

contract for the reason that Eastern Jackson County USSSA Umpire Association of Independence,

MO, is the only supplier of softball umpire services serving the eastern Jackson County area meeting

the County's requirements; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as

recommended by the Director of Finance and Purchasing and that the Director be, and hereby is,

authorized to execute for the County any documents necessary to the accomplishment of the award;

and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments including final payment on the contract, to the extent that sufficient appropriations to the

using spending agency are contained in the then current Jackson County budget.
